- Incomplete membership forms will not be processed. Double check all the blanks are filled in.
- The membership package to be submitted is 4 pages, not including a copy of your most recent report card. You must include a copy of your most recent report card.
- Completed membership applications & payments must be received in the AHSRA office a minum of 5 working days to ensure eliegiblity for the next rodeo entry date.
- Your district secretary will have your back number & membership card at the first rodeo you attend.
- After March 1<sup>st</sup>, new or renewing memberships must buy out a complete book of raffle tickets with membership.
